CHIEF WARRANT OFFICER 3 ALBERTO F. BOY DISTRIBUTION MANAGEMENT OFFICER, MCRD SAN DIEGO

Chief Warrant Officer Boy enlisted in the Marine Corps and reported to Marines Corps Recruit Depot San Diego, California in 2003 for Recruit training. Upon Completion of Infantry Training Battalion, Infantry Mortarman Course, Camp Pendleton, California he received the MOS of 0341 and was assigned to Weapons Company, 81's Platoon, 3d Battalion 1st Marines, 1st Marine Division Camp Pendleton, CA. Shortly after reporting in, Private First Class Boy became an Assistant Gunner.

In June 2004, Private First Class Boy deployed with Weapons Company, 3d Battalion 1st Marines to Fallujah, Iraq in support of OPERATION IRAQI FREEDOM 2 and 2-2. In July 2004, he was promoted to the rank of Lance Corporal and appointed as a 81mm mortar Squad Leader.

In September 2005, Lance Corporal Boy was meritoriously promoted to Corporal. Following his promotion, Corporal Boy deployed in September 2005 with 3d Battalion 1st Marines to Haditha, Iraq in support of OPERATION IRAQI FREEDOM 4-6 and 5-7 as the lead Vehicle Commander in a Mobile Assault Platoon.

In November 2006, Corporal Boy was promoted to the rank of Sergeant. In early 2007, Sergeant Boy deployed with Weapons Company, 3d Battalion 1st Marines on the 13th Marine Expeditionary Unit stopping again in Al Anbar Province, Iraq in support of OPERATION IRAQI FREEDOM 6-8. While on deployment on September 27, 2007, Sergeant Boy reenlisted in the United States Marine Corps.

In July 2008, Sergeant Boy deployed to Okinawa, Japan in support of the 31st MEU. Sergeant Boy was assigned as Section Leader, 81mm Platoon, Weapons Company, 3d Battalion 1st Marines. Upon his return, Sergeant Boy reported to the 15th MEU, where Sergeant Boy held the position of S-3 Training NCOIC/Police Sergeant.

In June 2010, Sergeant Boy report to Combat Instructor Course, School of Infantry West, Camp Pendleton, CA. Upon completion of the course, Sergeant Boy was assigned to Infantry Mortar Leader Course, Advanced Infantry Training Battalion. In February 2011, he was promoted to the rank of Staff Sergeant as well as reenlisting in the Marines Corps for his second time.

In May 2013, he reported to India Company, 3d Battalion 7th Marines, 29 Palms, CA where he was assigned as the 3rd platoon Platoon Sergeant. In September 2014, Staff Sergeant Boy deployed to Afghanistan in support of OPERATION ENDURING FREEDOM 132 & 141. Staff Sergeant Boy was awarded the Navy and Marine Corps Commendation Medal with Combat "V" for actions taken while on deployment.

In April 2015, Staff Sergeant deployed as India Company's Company Gunnery Sergeant to Al Jaber, Kuwait in support of OPERATION INHERENT RESOLVE 151 as a part of SPMAGTF 15.2 CR-CC. Staff Sergeant Boy reenlisted for his third enlistment in December 2015.

In April 2016, upon returning from the second deployment with 3d Battalion 7th Marines, Staff sergeant Boy received order back to Advance Infantry Training Battalion, SOI-West. Staff Sergeant Boy got promoted to the rank of Gunnery sergeant on August 1, 2016. Gunnery Sergeant Boy served as the Infantry Training Battalion Assistant Operations Chief. In January 2018, he submitted his Warrant Officer package and was selected for the 2019 Warrant Officer Basic Course with an MOS of 3102 Distribution Management Officer.

In February 2019, Gunnery Sergeant Boy was appointed to the rank of Warrant Officer and graduated from WOBC in May of 2019. Upon completion, Warrant Officer Boy attended his MOS school Distribution Management Officer Course at Marine Corps Combat Service Support School, Camp Lejeune, North Carolina.

In July 2019, he reported to Headquarters and Service Battalion, Marine Corps Recruit Depot, San Diego, California as the Installation Distribution Management Officer. In August 2020, Warrant Officer Boy was commissioned to Chief Warrant Officer 2. Then in August 2023, he was promoted to Chief Warrant Officer 3, where he currently still serves at the Distribution Management Officer.

Chief Warrant Officer Boy has a Bachelor of Arts, Management Degree.

Chief Warrant Officer Boy's personal awards include: the Navy and Marine Corps Commendation Medal (with Combat "V" and Gold Star in lieu of second award), the Navy and Marine Corps Achievement Medal, Combat Action Ribbon (with Gold Star in lieu of second award).

Chief Warrant Officer Boy is married to Kristen Boy. They have two daughters, Vivian and Alexis.
