Students cross Pacific to say thanks

MARCH

High school students from Kesennuma High School, Oshima Island, Japan came to the depot March 26, 2013, to visit with and thank Marines and sailors who assisted their nation following one of the deadliest natural disasters in history.

On March 11, 2011, a magnitude 9.0 under-

sea megathrust earthquake, now known as the Great East Japan Earthquake, occurred about 43 miles off the coast of Japan. The quake and the tsunami waves it generated, killed almost 16,000 people and injured 6,150. Another 2,643 are missing. The 133-foot waves traveled up to six-miles inland. The event destroyed almost 130,000 buildings, partially collapsed more than 254,000 others and damaged another 700,000.

The event also damaged the Fukushima Daiichi Nuclear Power Plant, generating the largest nuclear incident since the 1986 Chernobyl disaster in Russia, and the second (with Chernobyl) to measure Level 7 on the International Nuclear Event Scale.

Immediately following the tragedy the United States Marine Corps responded with Operation Tomodachi, a disaster relief operation.

More than two years later, the Kesennuma High School students came to say thanks to those who participated in the operation.

"I regretted not being able to thank the (Marines) then, because I couldn't speak English really well," said Mami Onodera, a 17-year-old, Oshima, Japan, native. "I couldn't express my feelings of how thankful I felt. When the school announced the program to send students here, I immediately thought this is the time when I can personally go and thank them."

The students were given a tour of the depot's command museum and provided lunch, accompanied by service members. Also joining the students was the Honorary Consul General of Japan in San Diego, and members of the Japan Society, the leading U.S. organization committed to deepening mutual understanding between the United States and Japan.

Marines get water survival training

Marine Corps Recruit Depot San Diego's function is to make new Marines. Part of making those Marines is to see to it that, even if they may not be comfortable in the water, they can function there

Recruit training goes on year round and each recruit must spend time in the water learning how to survive, how to take care of his fellow Marines and how to achieve his mission.

"Companies come to the swim tank during week four to get their water survival certification," said Staff Sgt. Patrick Sheedy, Marine Corps Instructor of Water Survival, ITC, Support Bn. "In order to receive a certification they must pass the basic swim qualification requirements."

Recruits are tested in five different events. The first event is a 25-meter swim in the shallow end of the pool wearing combat utilities and boots.

Upon completion, they move on to the second

event where they jump off a ten-foot tower into the deep end of the pool and swim 25 meters. For the third event, they must tread water for four minutes. During the fourth event, recruits jump into the

shallow end wearing a flak jacket, Kevlar helmet and a simulated rifle. They then have ten seconds to shed the gear while submerged.

The Honorable Raymond E. Mabus, Jr.

Parade Reviewing Officer

Ray Mabus is the 75th United States Secretary of the Navy and leads America's Navy and Marine Corps.

As Secretary of the Navy, Mabus is responsible for conducting the affairs of the Department of the Navy, including recruiting, organizing, equipping, training and mobilizing. Additionally, he oversees the construction and repair of naval ships, aircraft, and facilities, and formulates and implements policies and programs consistent with the national security policies established by the President and the Secretary of Defense. Secretary Mabus is responsible for an annual budget in excess of \$170 billion and leadership of almost 900,000 people.

Upon assumption of office and throughout his tenure,

Mabus has prioritized improving the quality of life of Sailors, Marines and their families, decreasing the Department's dependence on fossil fuels, strengthening partnerships and revitalizing the Navy's shipbuilding program.

Leading the world's only global Navy, Mabus has traveled nearly 715,000 miles to more than 95 countries to maintain and develop relationships with national and international officials and visit with Sailors and Marines forward deployed or stationed around the world. He has traveled to Afghanistan on 11 separate occasions, in recognition of the sacrifice and service of Sailors and Marines deployed in combat zones.

To prepare service members and their families for the high tempo operations of today's Navy and Marine Corps, Mabus announced in 2012 the "21st Century Sailor and Marine" initiative, designed to build and maintain the most resilient and ready force possible.

Mabus also directed the Navy

and Marine Corps to change the way they use, produce and acquire energy, and set an aggressive goal that no later than 2020, the Navy and Marine Corps obtain at least 50% of their energy from alternative sources. In pursuit of that goal the Department has achieved several milestones. In 2012, President Obama announced in his State of the Union address that the Department will purchase or facilitate the production of 1GW of renewable energy for use on Navy and Marine Corps installations. The Navy also demonstrated the Great Green Fleet in 2012, a carrier strike group in which every participating U.S. Navy ship and type of aircraft operated on alternative energy sources including nuclear energy and biofuels.

Secretary Mabus has made increasing the size of the naval fleet and protecting the industrial base a top budget priority of the Department. During his tenure, the Navy went from building fewer than five ships a year to having more than 40 ships

under contract, most of them in fixed-price, multi-year deals that assure value for taxpayers, certainty for industry partners

and strength for our nation. In June 2010, as an additional duty, President Obama appointed Mabus to prepare the long-term recovery plan for the Gulf of Mexico in the wake of the Deepwater Horizon oil spill. Mabus' report was released in September 2010 and met with broad bi-partisan support with most recommendations passed into law by Congress as the Restore Act. Included in the legislation was a fund to aid in the Gulf Coast's recovery by distributing 80 percent of any civil penalties awarded as a result of the damage caused by the disaster. To date, civil penalties total more than one billion dollars.

Before his appointment, Mabus held a variety of leadership positions. From 1988 to 1992, Mabus served as Governor of Mississippi, the youngest elected to that office in more than 150 years. Mabus was Ambassador to the Kingdom of Saudi Arabia

from 1994-1996 and later was Chairman and CEO of a manufacturing company.

Mabus has been recognized for his leadership of the Navy and Marine Corps on multiple occasions. In 2013, he was named one of the top 50 highest rated CEOs by Glassdoor, an online jobs and career community. Mabus was the only leader of a federal agency to receive this award.



Marine Iwo Jima vet visits MCRD

It has been 68 years since World War II ended. Not many people are given the opportunity to see or even speak to a World

War II veteran now. The Marine Corps Recruit Depot in San Diego was given the opportunity to not only meet a Marine Corps World War II veteran, but also got a chance to hear him tell his

John J. Devine, who is also one of the last remaining Iwo Jima survivors, spoke about his World War II experience at the depot, July 12.

In 1940, Devine joined the Marine Corps right out of high school at the age of 18. He had been looking for a different type of life, one that would give him the opportunity to see the world.

"I had joined the military for the travel and adventure," said Devine. "I originally tried to get into the Navy but the Marine Corps was always in the back of my mind because they have so much respect. Since the Navy

was slow to process me I went to the Marines and am glad I ended up there."

Coming back to MCRD brought back memories of Devine's own recruit training experience. Devine recalled his training as a hard but an overall positive experience. Devine said that his drill instructor was a good man and had nothing but good memories of him.

"I just went along with the program and didn't fight it," said Devine. "The hardest part of recruit training was the bayonet course. I had stabbed the dummy so hard with the bayonet that I wasn't able to pull it out!"

Devine had joined the military before America was at war. It wasn't long after though that he would learn he would be sent to war to defend his country.

Marine Vietnam vets awarded Silver, Bronze Stars

Forty-six years ago, a company of Marines fought up Hill 881 South during the First Battle of Khe Sanh April 30, 1967, one of the bloodiest battles of the Vietnam conflict.

Courageous and heroic efforts were common, but with a 75 percent casualty rate, heroic actions of some Marines were left untold until two Vietnam veterans were awarded the Silver and Bronze Star medals in ceremonies held at Marine Corps Recruit Depot San Diego, Sept. 20.

Joe B. Cordileone was awarded the Silver Star medal and Robert T. Moffatt was awarded the Bronze Star medal with combat distinguishing device aboard the depot.
